



SITTER AGREEMENT *For Churches and Schools*

Client will need to do an online profile and submit sit requests through the online system.

- Client agrees to:
 - Pay NH via credit card charged a \$100 application fee (Annual renewal fee is \$25.) *(unless you are an existing client for other services)*
 - Pay NH via credit card charged \$5 per hour *(with 3/hr minimum and 24hr notice)*
 - Pay Nanny via cash/check: \$15 per hour with 3-hour minimum *(more than 4 children subject to higher fee)*
 - Pay a \$20 rush fee via credit card charged for requests to be filled 24 hours or less.
 - Pay a \$30 cancellation fee via credit card charged for all cancelled, confirmed jobs. (\$25 goes to the sitter) *(Long-term assignments are subject to a cancellation fee of \$25 per day of confirmed assignment.)*
 - If sitter is not compensated correctly, or hourly minimum is not met, client will be charged the difference so that we may compensate the sitter. Hourly rates are subject to change, but families will be notified of rates on the online sitter request form page.
- If Client uses the NH on-call sitting service, Client agrees to pay agency fees for each Nanny candidate sent to them. Fees to the agency must be paid in advance and fees paid to the nanny must be paid upon completion of the assignment. After a non-refundable \$100.00 application fee and this Sitter Agreement have been received by NH, a nanny's name and number will be sent via email to the Client. It is the Client's responsibility to contact the nanny.
- Client agrees not to hire any of the nanny sitter candidates sent to them without consulting Nannies from the Heart prior to hiring. Client also agrees not to make private arrangements for nanny sitter candidate to work without contacting Nannies from the Heart prior to each visit. Any such action would require a referral fee based on fees published at www.nanniesfromtheheart.com. All information provided to the client on each nanny sitter candidate is **confidential** and is not to be shared with any other parties outside this contract. Doing so will obligate Client to all fees owed for referrals or sitting services from the other parties. It is understood that NH is neither the Employee nor the Employer in this agreement, but is acting independent of the Client and the prospective nanny sitter. NH is an independent contractor and is not the agent of the Client or nanny.
- NH cannot guarantee the honesty or reliability of the nanny sitter. NH is not the agent of the nanny. Accordingly, the Client hereby releases and agrees to hold NH, its directors, officers, attorneys, successors, and assigns, harmless from any act of negligence, gross neglect, nonfeasance, misfeasance, or malfeasance, by the nanny sitter.
